4. All purchases are subject to a 13.5% Buyer's Premium; 3.5% discount for cash or check payment.
5. Every item is sold "as is". Neither the auctioneer nor the seller makes any warranties or representations or any kind of nature with respect to said property. All sales are final. Catalog descriptions are for simple identification purposes only, no representation are made as to authenticity, age, origin or value.
